



RULES OF PROCEDURE

I. WORLD FEDERATION

1/ **Xuân Long Phái World (XLP WORLD)** is an international federation of associations and unions or federations that wish to practice Xuân Long Phai.

2/ The XUÂN LONG VIETNAMESE KUNG-FU or XUÂN LONG PHAI school comes from the Quan Ky style, from which it proposes a continuity in practice and transmission according to its own technical direction, values and federal dynamics.



3/ **The crest** official of Xuân Long Phái consists of a golden yellow dragon in a circle with a red background; surrounded by a large circle with a blue background with the words:

- "XUÂN LONG PHÁI": *in white characters which translates: "The Spring Dragon School";*

- "春龍派": *in white characters which translates: "The Spring Dragon School";*

- "中越拳術": *in black characters which translates: "Sino-Vietnamese Martial Arts";*

- "VIETNAMESE KUNG-FU": *in black letters;*

surrounded by a thin red circle, itself bordered by a slightly thicker circle of golden yellow.

Only the World Federation is allowed to manufacture and sell the official crests. Clubs and unions/federations will be able to order the badges from XLP WORLD.

4/ **Practitioners** wear a black vo-phuc with yellow edging on the collar (Qwan Ki Do type) with the official patch worn at the level of the heart, a belt corresponding to their level in the Xuân Long Phái school and a grade patch (for 1st dang and above) worn on the right side of the jacket. A club crest is tolerated on the left shoulder.

5/ Martial arts club members commits to be in compliance with the legislation concerning the practice of martial arts in force in their country.

6/ **XLP WORLD** may partner with other international martial arts organizations.

II. ADMINISTRATION

1/ The Board of Directors was initially composed of four members, including Mr. Frédéric Germain, the founder of Xuân Long Phai.

The Board of Directors may be expanded upon a proposal from the President or the General Manager, subject to the approval of the General Assembly.

The Board of Directors, including its officers, is renewed by one-third every two years, subject to the approval of the General Assembly.

The Board of Directors meets annually in September to prepare for the season and whenever necessary for its smooth operation, at the invitation of the President.

The General Assembly meets annually in June.

2/ The General Director (“Giám đốc”)

Mr. Frédéric Germain, founder of Xuân Long Vietnamese Kung Fu, holds the title of General Director (“Giám đốc”) of the Xuân Long Vietnamese Kung Fu school, which he founded on February 10, 2024.

The General Director is a permanent member of the Board of Directors. He has veto power over any decisions that could harm the martial art he teaches or the reputation of his school.

III. MEMBERSHIP

1/ Martial arts clubs or federations can join XLP WORLD by completing the annual membership application and paying the annual fee.

A club's annual membership automatically includes the membership of all its members.

2/ The annual fee is set at: €100 per club or €500 per union or federation.

This fee allows clubs to:

- be identified with the emblem and name: "Xuân Long", "Xuân Long Phai", "Xuân Long Kung-Fu";
- participate free of charge in training courses offered by the KfV FRANCE Technical Directorate;
- take Xuân Long Phai and Cô Vo Dao school ranks;
- be listed on the website: www.xuanlongphai.org;
- To obtain an official email address, such as: clubname@xuanlongphai.org

4/ Active members are:

- Members of the Board of Directors (exempt from annual dues);
- Presidents of clubs, unions, or federations who are up-to-date with their annual dues.

5/ Practitioners assigned a mission by the Technical Director may be reimbursed with the President's approval.

Practitioners assigned an administrative or representational mission by the President may be reimbursed under the President's responsibility.

All reimbursements must be presented to the Board of Directors.

6/ The expulsion of a member of the Board of Directors or a president of a club, union, or federation is decided by an absolute majority of the Board of Directors and the General Director for non-compliance with the internal regulations. The person in question will then be summoned. After hearing the

individual's explanation, reasons for the summons, and arguments, the Board of Directors and the General Director will take a decision.

IV. TECHNICAL DIRECTION

1/ The XLP WORLD federation has as its Technical Director Frédéric Germain, founder of the Xuân Long Phai, 6th dan expert of the French Karate Federation.

2/ The mission of the Technical Director is to ensure quality training for practitioners, teachers and managers so that everyone can flourish and evolve by following the path of traditional martial arts.

3/ The technical referents and commission managers are appointed in each country by the Technical Director for a renewable period of 2 years. They are responsible for assisting the Technical Director in his mission.

V. TRAINING

1/ The Executive School

The Executive School directed by the Technical Director each month in France is opened at all practitioners from the level of black belt. It is a free activity for participants.

At the international level, this same program will be communicated to the Technical Managers of the XLP WORLD member clubs/federations with educational materials.

2/ Training courses

Training courses can be organised at the request of federations/unions or clubs.

Trainings led by *Vo Su* Frédéric Germain, Technical Director Xuân Long Phai

Modules: Noi Công (1h) / Xuân Long Phai (1h30) / Cô Vo Dao (1h): *Bông and/or Guom*

Typical organization and prices:	- 1 session of 3 modules over 1/2 day:	800 €
	- 2 sessions of 3 modules over 1 or 2 days:	1400 €
	- 3 sessions of 3 modules over 2 days:	1800 €

Additional costs: Travel, accommodation and food expenses are the responsibility of the organizer.

VI. EXPENSES

1/ The Technical Director, or the technical referent commissioned by the Technical Director with the agreement of the organizers, are paid the amount of the course paid by the organizer to XLP WORLD by bank transfer or in cash. Expenses are paid with a mission sheet signed by the President and the beneficiary. The rates may be modified by simple decision of the Board of Directors.

2/ Practitioners in charge of an administrative or representative mission given by the President may be reimbursed under his responsibility.

3/ All expenses incurred must be presented to the Board of Directors.
